Building Plan approval (WBIDC)

- 1) Certificate of empanelment of Structural Engineer including structural stability certificate duly signed by the concerned empanelled Structural Engineer as per rule
- 2) Copy of application made to WBSEDCL/CESC/any other Power Supply and Distribution Company
- 3) Copy of Deed and Deed plan
- 4) Current paid up Municipal or Panchayet Tax receipt/ Current year paid up tax receipt applicable for the specified area. (if applicable)
- 5) Detailed Architectural drawing(s) (in ".dwg" format) as per provision of WBMBR, 2007 (as amended) with specifications of the work. Only 1 dwg input file in 1 application
- 6) Detailed calculation of structural design as per provision in these rules self or by structural engineer attested
- 7) Detailed Structural drawings (in AutoCad software) including a copy of detailed structural analysis structural design Calculation in STAAD input and output files abiding West Bengal Municipal Building Rules,2007
- 8) FAR calculation sheet including Built-up area and construction area statement of the proposed Industrial/Commercial buildings, etc. certified by the applicant and concerned Architect
- 9) Indemnity Bond (along the lines of form L of WB Municipal (Building) rules, 2007)
- 10) Revised Fire Safety Recomendation of building issued under the West Bengal Fire Services Act, 1950
- 11) Sanctioned plan in case of any existing structure for extension and renovation
- 12) Submission of duly filled Form B in all aspects
- 13) Utility Plan: Drainage Plan showing proposed layout for drainage of both storm and treated Septic Sewer along with water requirements computations and setting up other treatment plants(if any)

- 6) Plinth level permit

Plinth level completion (WBIDC)

- 1) Any other document in case of deviation from sanctioned Plan
- 2) Building permit/approved building plan documents
- 3) Deviation Plan, if any as per Rule 31 of WBMBR,2007
