WHEREAS Silpasathi, the Single Window Portal ([www.silpasathi.wb.gov.in](http://www.silpasathi.wb.gov.in)), have the provisions for the investors to obtain licenses/registration/approvals/ NoCs online from a single point for setting up industries and operating business in the State.

AND WHEREAS the following service of WBIDC under Department of Industry, Commerce & Enterprises, Government of West Bengal has been integrated end to end with the State Window Portal.

AND WHEREAS the Department of Industry, Commerce & Enterprises, Government of West Bengal vide No.219-ICE-11012(13)/5/2022-ESTT dated 28.12.2022 has decided that the following service will be routed only through Silpasathi portal.

Now, therefore, the above mentioned service will be provided exclusively through State Single Window portal Silpasathi and all applications are to be submitted online through this portal only with effect from 1<sup>st</sup> of January 2023 instead of standalone system.

For Registrations/Licences/Approvals availed through standalone system before 1<sup>st</sup> January, 2023, the renewal of such Registrations/Licences/Approvals will be issued from the standalone system.

All concerned will take necessary action accordingly.


