NOTIFICATION

No. 809-PO/O/C-IV/1E-132/13.—17th December 2013.—In exercise of the powers conferred by sub-section (2) of section 3 of the West Bengal Right to Public Services Act, 2013, the Governor is pleased hereby to notify the services along with the stipulated time limit for rendering the services, the Designated Officer responsible for providing the services, the Appellate Officer and the Reviewing Officer as follows :—

2. In respect of services mentioned in serial number 11 to 15, there is already statutory provision for designated authorities upto Appellate Authority in the Electricity Act, 2003/W. B. Lifts & Escalators Act, 1955 and there is no provision for Reviewing Authority therein. If there is any amendment in those Acts & Regulations in future as to various designated authorities, or the time limit for providing services, the same will be applied *ipso facto* to the provisions in this Notification relating to the said services.

3. No service mentioned in this Notification will be subject to any service tax since the services provided are in the nature of statutory obligations which are to be fulfilled in accordance with the Electricity Act, 2003, W. B. Lifts & Escalators Act, 1955 and the Rules & Regulations made thereunder.

4. CEI/Jt. CEI/Dy. CEI/EI mentioned in this Notification are posted in the Directorate of Electricity at 11, Netaji Subhas Road, Kolkata-700001.

This Notification shall come into force on the date of publication in *The official Gazette*.
