Food Safety Standards (Licensing and Registration of Food Business) Regulations, 2011

All Food Business Operators (FBO) will be registered or licensed in accordance with the procedures laid down.

Depending upon the eligibility FBO may fall under State License (Application Form-B) or Registration(Application Form-A).

FBO like manufacturers, storage, transporters, retailers, marketers, distributors need to take a license from State Authority.

'Registering Authority' means Designated Officers notified as such by the State Food Safety Commissioner.

'State Licensing Authority' means Designated Officers appointed by the State Food Safety Commissioner.
