- 1:0: Purpose:** The purpose of this SoP is to establish the procedure for processing and disposing application for issuance of Registration Certificate for Manufacturers / Importers/ Packers under Legal Metrology (Packaged Commodities) Rules, 2011. This SoP is prepared under rule 19(iii) of West Bengal Right to Public Services Rules, 2013.
- 2:0: Scope:** This SoP envisages for processing and disposal of application for issuance of Registration Certificate for Manufacturers / Importers/ Packers under Legal Metrology (Packaged Commodities) Rules, 2011 within the stipulated time as notified/ or may be notified time to time under sec. 3(2) of the West Bengal Right to Public Services Act, 2013. This SoP specifies documents to be submitted along with application and specifies offices for submission of application. It also envisages the legal requirements i.e. maintenance register, submission of report under Legal Metrology (Packaged Commodities) Rules, 2011 and West Bengal Right to Public Services Rules, 2013. This SoP only partially modifies memo. No. Kg-L/72 dt. 25.04.2013 and memo. no. CLM/Lic/329 dt. 14/07/2015 of CLM, West Bengal.
- 3:0: Definition:** This SoP for disposing application for obtaining fresh Registration Certificate adopts the following definition in its framework
- (i) **Application:** means (in) appropriate form as developed and freely distributed by this Directorate. The application form is available and downloadable at [http://wbconsumers.gov.in/HtmlPages/lmo\\_forms.aspx](http://wbconsumers.gov.in/HtmlPages/lmo_forms.aspx) . The application shall contain all information as mentioned under rule 27(2) of Legal Metrology (Packaged Commodities) Rules, 2011.

- (ii) **Electronic Record (ER):** is defined under section 2(t) of Information Technology Act, 2000 as ‘data, record or data generated, image or sound stored, received or sent in an electronic form or micro film or computer generated micro fiche.
- (iii) **Information:** includes all data, message, text, image which require(s) to be subscribed by the applicant(s) to best of his/her/their knowledge for factual correctness and/or the applicant(s) want(s) the inquiry/recommending or licensing authority to believe to be true to act upon, under certification in the applications as mentioned in terms of rule 27(2) of Legal Metrology (Packaged Commodities) Rules, 2011;
- (iv) **Registration Certificate:** means (in) appropriate form containing name, complete address and commodity(ies) pre-packed or imported by applicant, issued by the Controller of Legal Metrology under rule 27(1) of Legal Metrology (Packaged Commodities) Rules, 2011;
- (v) **Registration fees:** means fee of Rupees Five hundred (Rs.500.00) only as per rule 27(1) of Legal Metrology (Packaged Commodities) Rules, 2011. Such fees to be remitted under head of account 1475-00-106-001-12 through GRIPS
- (vi) **Requisite Documents:** means and includes authenticated copy of enclosures as mentioned against Packers Registration in ‘SoP in respect of services provided by the Legal Metrology Directorate under West Bengal Right to Public Services Act, 2013’ issued vide no. CLM/Lic/329 dated 14.07.2015. The requirements of documents for issuance of manufacturers/ dealers/ repairers licenses are mentioned below.

**4:0: Responsibilities:** The issuance of Registration Certificate for Manufacturers / Importers/ Packers under Legal Metrology (Packaged Commodities) Rules, 2011 viz-a-viz West Bengal Right to Public Services Act, 2013 requires general and specific responsibilities which are mentioned herein under:

- (i) All application and necessary documents for license shall be received in the Licence Section of Directorate of Legal Metrology, West Bengal against issuance of Form I and entry in Register in Form IV under West Bengal Right to Public Services Rules, 2013. If

The Licensing Section describing summary of deficiency in Form I and Register in Form IV shall be updated accordingly.

(ii) If the application and necessary documents is deficient in any information or requires further clarification, the DCLM in charge of Licence Section of this Directorate shall obtain such clarification in concurrence with CLM. Upon the receipt of clarification, DCLM in charge of Licence Section of this Directorate shall put up for disposal of application of issuance of registration certificate as per rule.

(iii) The CLM, WB shall dispose the application for issuance of registration certificate and as per rule 29(1) of Legal Metrology (Packaged Commodities) Act, 2011, shall cause to maintain records of issued Registration Certificate, which is open for public inspection free of cost. He shall also cause to update Register in Form IV under Right to Public Services Rules, 2013. In terms of rule 30 of Legal Metrology (Packaged Commodities) Act, 2011 a compiled list of the manufacturers and packers registered under rule 29 shall be circulated among the Controllers of concerned States and shall be uploaded quarterly in the website [http://wbconsumers.gov.in/HtmlPages/lmo\\_forms.aspx](http://wbconsumers.gov.in/HtmlPages/lmo_forms.aspx) as valid publication.

**8:0: Procedure:**

- (i) All application and necessary documents for registration certificate shall be received in the Licence Section of Directorate of Legal Metrology, West Bengal against issuance of Form I and entry in Register in Form IV under West Bengal Right to Public Services Rules, 2013. The GRIPS paid Challan shall be verified in website<sup>1</sup>. If the application is incomplete, it should be returned immediately or as per rule 27(4)(a) of Legal Metrology (Packaged Commodities) Rules, 2011 within seven (7) working days from the date submission of application, to the applicant(s) describing summery of deficiency in Form I and Register IV shall be updated accordingly.
- (ii) If the application and necessary documents is deficient in any information or requires further clarification, the DCLM in charge of Licence Section of this Directorate shall obtain such clarification in concurrence with CLM. Upon the receipt of clarification, DCLM in charge of Licence Section of this Directorate shall put up for disposal of application of issuance of registration certificate as per rule.
- (iii) The CLM shall dispose the application either by registering the applicant and issuance of Registration Certificate under rule 27(4)(b) of Legal Metrology (Packaged Commodities) Rules, 2011 or reject the application by passing reasoned order. As per rule 29(1) of Legal Metrology (Packaged Commodities) Rules, 2011, records of issued Registration Certificate shall be maintained by the Licensing Section of this Directorate, which is open for public inspection free of cost under rule 29(2) of Legal Metrology (Packaged Commodities) Rules, 2011. Register in Form IV under Right to Public Services Rules, 2013 shall be updated accordingly. In terms of rule 30 of Legal Metrology

(Packaged Commodities) Rules, 2011 a compiled list of the manufacturers and packers registered under rule 29 shall be circulated among the Controllers of concerned States and shall be uploaded quarterly in the website [http://wbconsumers.gov.in/HtmlPages/lmo\\_forms.aspx](http://wbconsumers.gov.in/HtmlPages/lmo_forms.aspx) as valid publication.

(iv) Two (2) copies of Registration Certificate shall be prepared. One copy shall be sent to the Applicant by registered post. Second copy of Registration Certificate shall be kept for record in the Directorate. All the associated documents of the Registration Certificate shall be considered as A (i.e. Permanent Record) as per Rule 90 of Bengal Record Manual, 1943. Electronic records (ER) as generated for preparation of the Registration Certificate shall also be retained securely.

(v) The maximum time limit for disposal of application is fixed at Seventy five (75) working days from the date of receipt of application in the Licensing Section<sup>2</sup>.

(vi) All the application along with documents received by the Directorate of Legal Metrology shall be processed the application following the note sheet as shown in Appendix I. Individual leaver file (i.e. preferably Cobra File or similar brand) shall be maintained to process each application. For processing of Registration Certificate blue coloured file shall be maintained. Such colour coding shall help to identify the file at ease.

(xi) Maintenance of unique identity number of Registration Certificate is required. Each Registration Certificate shall bear following numeric number. Following NIC Coding system (i.e. NIC-LRISD-001(NICSI/70182, August 2008), the following coding pattern shall be maintained. Each license shall bear 14 digit numbers. First two digits shall identify the state and presently it





will be 19. Next two digits shall identify districts. District code (dcode) as use by revenue administration is as follows, which can be adopted here. Place of issue of Registration Certificate shall be of one digit (i.e. 1 for Kankurgachi). Inspectoral unit shall be of four digit alpha numeric number i.e. first three digits shall be of numeric number and fourth digit shall be of alpha type. License type shall bear one digit, i.e. 4 for registration certificate. All the Registration Certificate issued previously shall be re-numbered based on the procedure above and the applicant shall be intimated accordingly.
