

Brief of the Reform

After the introduction of e-Deed facility in the month of December 2019 the entire process of registration was made online and would be completed without visiting office.

At present e-Assessment is done first by the applicant with their Mouja/Plot details submitted electronically and the deed may be prepared electronically in predefined format as well as electronic execution (Aadhaar based e-Signing) and submission of executed document for registration.

This e-deed facility replaces the manual process of deed preparation and it reduces time and efforts of the business/industries as well as citizens to a great extent.



Process Followed

The system was planned to for wider public use

Timeline reduced from 1 month to 1 day

In May, 2020 e-Registration and e-Appointment facilities were introduced in eNathikaran system along with prevailing mode of registration.

Government Process Re-engineering was done, while ensuring adherence to both state and central statutory and regulatory mandates pertaining to registration procedure
