ORDER

The Governor is pleased to declare M/s West Bengal Electronics Industry Development Corporation Limited(Webel) to act as the State Level Nodal Agency(SLNA) for the purpose of setting up and managing the Cyber Security Centre of Excellence(CS-CoE).

2.The Scope of activities are as follows :-

a. Webel shall set up the CS-CoE at 'Utility Building' Plot No-AI-164/1,Premises No-09/1-0024,Action Area-1A,New Town,Kolkata-700 150 by entering into an agreement with West Bengal Housing Infrastructure Development Corporation Limited;

b. The Cyber Security Centre of Excellence (CS-CoE) shall be funded and managed by Webel and the required funds for management shall be reimbursed by the State Government in the Department of Information Technology & Electronics in due course;

c. Webel shall prepare a detailed 'financial estimate' for capital expenditure and subsequent operational expenditure for the CS-CoE. Based on which, a tentative budget ought to be submitted to the Department of Information Technology & Electronics ,Government of West Bengal seeking seed money/ sanction of funds.

d. Besides, Webel shall function as the 'State Implementing Agency' (SIA) for all activities of CS-CoE until further order.
