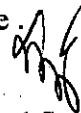
To upgrade the existing system of licensing of selling of Modern Drugs under Directorate of Drugs Control, WB under the Drugs & Cosmetics Act, 1940 and Rules made thereunder and to make it more accountable, transparent and user-friendly, it has been decided that henceforth such licensing procedure will be carried out by using a web-based software developed by this Deptt named 'e-Vesaj'.

2. Accordingly, the undersigned is directed to say that the Governor has been pleased to introduce the use of software based licensing system in a phased manner for all districts commencing with the first phase in Kolkata H.Q. on and from 30th January, 2017 and all other districts by 30th June, 2017.

3. The applicants for new or renewal of license have to apply using the e-Vesaj system which is hosted in the Departmental website 'www.wbhealth.gov.in'. They are to log on the tab 'e-Vesaj' for detailed procedure of application along with the necessary 'User manual'.

4. Unless mentioned otherwise, the existing paper based application will not entertained by the Directorate of Drugs Control from 30th January, 2017. The licensing authority will issue the License itself after due processing of application using this software and inspection thereof.
